Healthcare organizations are becoming **attractive targets**, due to the amount and value of data that is stored on their systems.



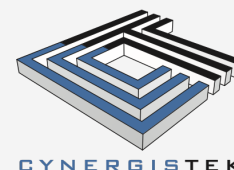
